After the meeting Cllr D A Williams declared an interest in items 8f) Carr Wood Boardwalk and item 9) Grant cheque for Friends of Carr Wood as treasurer for the group but remained in the meeting and took no part in the items discussion

6863. Public speaking – Cllr R Emmas-Williams spoke of the very sad passing of David Neilson who had been a Town Councillor and served the people of Ripley from 1974 to 2011 when he retired from the Council after 37 years of which he was Town Mayor in 1982/83. Everyone valued his local knowledge on topics going back many years for which he will be sadly missed the funeral will take place on Friday 20th June at 11.45am at Wood Street Chapel. A minutes silence was held in memory of David.

Cllr R P Ashton spoke to thank the Police for their support for the St Georges Day Parade and they did an excellent job.

Cllr R P Ashton asked as AVBC have designated Ripley as a deprived area will the car parking charges be reduced or indeed would the car parking become free in Ripley?

Cllr A Bridge asked if the Police would look into the parking on pavements on Rowan Avenue as vehicles are parked in such a way that wheelchairs nor mobility scooters can continue along the footpath they have to go onto the road to bypass the parked vehicles.

PC R Marshall stated that he had visited Rowan Avenue but had found no problems, he would look again.

Cllr S Daley spoke of the same problems on Crossley Street and PC M Reddish, when in post, managed to clean up the problem.

PC R Marshall stated he would also look into this and also spoke of the next Panel meeting and would be setting the three new priorities for Ripley.

Cllr D A Williams thanked the Police for responding regarding the parking problems and noted that Crossley Street residents had previously car stickers to show who were residents and stated that there is a car park available.

PC R Marshall stated that the Police would look into this.

Cllr Ms L D Cox responded to Cllr R P Ashton regarding the car parking fees, this is an issue that was raised in their manifesto and would be looked into.

PC R Marshall spoke of parking problems would be followed up but they had concentrated on crime and the statistics showed they had reduced crime as shoplifting had reduced by 25%, theft from vehicles had reduced by 81% and house break-ins had reduced by 69%. There is a new Sergeant Paul Stevenson at Ripley and a new PC would be in post from Belper as PC Dan Quick had been posted to Heanor. The new CCTV have all angle cameras which will help the Police. The question was raised about the toilets on Crossley Park not being open at the weekends when there are many elderly people and families with young children needing to use the toilets. Also the Market Place toilets would need to be open later for the Fair in October. A new scheme the Police were working with for low level offenders to put something back by litter picking and they had spent a 45 minute session on the Greenway which had proved very useful and diverts people from the court system.

A resident spoke of several areas of Ripley that could benefit from litter picking and thought this is a very good idea.

Cllr S Freeborn thanked PC R Marshall and noted that the crime stats were very encouraging and working with youngsters is great and nips problems in the bud. Regarding the Market Place toilets please liaise with the Clerk and this will not be a problem, the disappointing news that PC D Quick, who has been with us for five years is being moved to Heanor. It is perplexing as he has built up local knowledge and was known in the town, the Clerk will write to the Chief Constable thanking PC Quick for his work during the five years he was with us.

Cllr R Emmas-Williams stated that the Crossley Park toilets were open last Sunday for the Band Concert.

Cllr Ms L D Cox also spoke of thanks to the Police for their efforts.

Cllr M Wilson gave his congratulations to Cllr Emmas-Williams being elected as Town Mayor and stated how pleased he was that the crime stats have reduced but an observation was that at 8.00am in the morning there are very few cars in Ripley.

lan Fisher spoke of the confusion regarding nominations for the William Holmes Almshouses at the top of Fletcher Street where six bungalows were built and money was left for maintenance with five trustees and two named representatives on behalf of Ripley Town Council who would be trustees for a four year term. Gerry Fryer has been Clerk to the trust and he would like to thank him for all his work. The properties are for elderly residents from the Ripley area, which will free up a family home, the rents are not extortionate, six have had new boilers fitted and four have had new kitchens. There is a difficulty finding residents as there is no car parking. Could Ripley Town Councillors consider if they are aware of anyone who might benefit from living in these properties and then start a waiting list?

Cllr S Freeborn thanked Ian for the information and the Town Council nominations are for Cllr R Emmas-Williams and Ian Fisher for the next four year term and if anyone knows of people who could benefit from these properties to please inform our Clerk and she will pass on the details to the trust.

Town Mayor's Announcements – Sunday June 1st attended the Brass Band Concert by the Newhall Brass Band in Crossley Park - Tuesday June 3rd attended Ripley Junior School Summer Fayre – Sunday June 8th invitation to attend the 1940 weekend at Midland Railway which was absolutely fantastic – Thursday June 12th attended Ripley Hospital to celebrate the Ripley League of Friends handing over a new ultrasound machine – Sunday June 15th attended the Brass Band Concert played by the Newstead Brass Band in Crossley Park – an invitation is extended for all to attend July 19th / 20th to Patrons of Duchess of Sutherland Open Day from 10.00am to 4.30pm – also flowers were sent to Liz Hawkins (Cllr S Daley's partner) from the council as she has had two serious operations; her thanks for this kindness has been received..

Cllr R Emmas-Williams then spoke of his pleasure in making a presentation to ex Councillor Maurice Gent of a special Certificate of Merit Award and a Denby Plate specially made depicting Maurice's name and long service at the Town Council, where he served as Town Mayor in 1981/82, 1885/86 and 2000/01. Cllr R Emmas-Williams wished Maurice and Desiree well for a long and healthy happy retirement; they both deserve it after the service given to the people of Ripley Township.

6867. Report of the Town Clerk on: -

- a) New Website update all Bio's now received and website will be live after checking content RESOLVED the Clerk is to chase up the provider and ask that the website be up and running as soon as possible and asked all Councillors to contact any local groups they are aware of to send links to the Clerk to be added to the website
- **b)** Butterley Brick Works Football Pitch update Cllr D Williams reported that discussions with agents and others regarding options available are on-going.
- c) Neighbourhood Plan and AVBC Core Strategy suspension update Cllr S Freeborn spoke of the AVBC Core Strategy being suspended and it has to be brought in line with the Inspectors comments, and that AVBC are hoping this will happen by November. The Ripley Neighbourhood Plan is still continuing and there has been a legal precedent, the Tatton hall ruling. Where a Core Strategy is not in place and a Neighbourhood Plan has been approved, then the Core Strategy has to conform to the Neighbourhood Plan. In the N Plan there will be some changes by removing some of the building proposals in the plan. The Steering Group are meeting next week to discuss final comments received from the many consultations held and then when completed, the plan will be submitted to the Inspector. When approved the N Plan will then go out to a referendum, hopefully in the Autumn.
- **d) Hanging Basket and planters –** the Clerk reported that the hanging baskets would be installed on Friday June 20th 2014
- e) Ambergate Cricket Club Ground update –Cllr S Freeborn reported that the land has been sold to a third party, at present it is not known who this is. This is very disappointing to the Town Council and the Ambergate Cricket Club as it was hoped to facilitate the club continuing to use the cricket ground. Offers were to be made, above the accepted amount but the Agent did not recognise this and the land was sold. We will continue to look into this.
- f) Carr Wood Boardwalk request for funding for the Boardwalk RESOLVED the Clerk is to write to AVBC with a view for both Councils to fund the £1760.00 + vat on a 50% each basis
- g) Local Works asking for support from the Council regarding rate paying businesses in the area that the Local Council receive, say, around 5% of the business rates which would then benefit the local communities - RESOLVED to support this and welcome any monies from the rates collected by the Borough Council
- h) Ripley and Amber Valley Lions Club looking for a "Community Clean Up Day, Tree Planting Project, clean up a vacant plot or help the elderly with their gardens" - RESOLVED for Councillors to let the Clerk know of areas that may require trees or elderly or vulnerable people that may need help with tidying their gardens

- i) Grit Bin required for Limes Park RESOLVED to remove this item from the agenda
- j) Leonard Cheshire Disability request for funding for transport to a disability sports event at West Park Long Eaton cost between £300.00 and £400.00 (six people from Ripley enjoy the services of the group) - RESOLVED the Clerk is to write to ask how many people from Ripley Township are actually going on the trip and if satisfied there could be a donation of up to a maximum of £400.00 (to be determined by the Mayor and Deputy Mayor.
- **k)** Ripley & District Branch of the Royal British Legion request for support towards costs of running the Remembrance Parade and Service November 9th 2014 **RESOLVED** the Clerk is to contact the branch and ask what particularly they are doing special this year and what any funding would be for.
