5785. Public speaking – (10 Minutes)

Cllr R P Ashton spoke expressing thanks to the people of Ripley and two schools and the children presented with a wreath, poppies and t-shirts plus their singing, there was a very good effort from all. Sunday Remembrance was well supported and thanks again to the Ripley people for supporting and attending the parade and service.

Mr College presented a petition to the Ripley Town Mayor Cllr Michael Missett and spoke of the difficulties and road safety matters on Bridle Lane Ripley. Mr College spoke as one of the residents of Bridle Lane and due to the properties not having any footpath in front of the properties the amount of vehicles which do not drive slowly or carefully the road has become very dangerous. Mr College asked if temporary speed humps could be installed to slow the traffic down and make the road safer.

Cllr S D Freeborn thanked Mr College and the rest of the residents for the petition which is noted as received and asked the Police and Cllr D Bowley could be of help as he is also a County Cllr.

Cllr D Bowley had been informed of the problems by Cllr S Joynes and he had spoken to Derbyshire County Council and they have said they will do a survey.

Cllr D A Williams spoke of his sympathy with the residents and the hedge had been cut back by Amber Valley Borough Council to help pedestrians.

Mr College stated that they had managed to get Sainsbury's to cut the hedge after six years some of the trees have TPO's on them.

Cllr Ms L D Cox spoke to remind the public of the consultation Derbyshire County Council are having regarding switching off 40 thousand lights between 12.00 midnight and 5.30am and 400 hundred in other areas and encouraged the public to contact Derbyshire County Council to state their views. Ripley Town Council have made representation.

Cllr D Bowley stated if there are problems they could be switched back on.

PC M Reddish spoke of his support for Mr College and the problems on Bridle Lane there is no footpath and it is a busy thoroughfare.

Mr College spoke of a post that used to be in place which stopped motorcyclists but Access had removed this.

Cllr D Bowley stated he would look into the land ownership.

PC M Reddish spoke of Remembrance Sunday he thought there were at least 300 to 400 people attended and the Police had kept Church Street closed, however there were so many people in a way they closed the road by their number. Next year this would be looked at for closing the road again.

Previously dwelling burglaries had been raised, now the overall crime for Ripley Town was down 13.4% down on last year. Theft from vehicles and dwelling burglaries were up but there is a program to try to deal with these.

The Police are looking to maintain the Police Office in the Old Town Hall on Monday, Wednesday and Fridays and the Safer Neighbourhood Team are trying to keep the office open, any issues please contact PC Reddish at the office.

Cllr S D Freeborn stated that the future tenancy for the Police is more secure with the progress of Ripley Town Council taking over the Town Hall.

Cllr S D Freeborn also spoke of Remembrance Sunday, he felt that the road being closed added to the dignity of the occasion and is pleased that the Police are looking to this again for next year and thanks the Police for this and the work they do.

Cllr K Buzzard also thanked the Police and thought the road closure was much better.
